

CERTIFICATED/LICENSED MEMBERSHIP DUES FOR THE 2025-2026 SCHOOL YEAR

Any person who is engaged in or who is on a limited leave of absence from certificated/licensed education work. Active certificated/licensed members shall be employed in a position requiring a certificate/license of qualification granted by the State Board of Education or by the Illinois State Educator Preparation and Licensure Board or employed in a faculty position in an institution of higher learning, including faculty regularly employed by an institution of higher learning but who are not assigned a class in one or more semesters in an academic year for as long as such person is eligible for active membership in his or her local or for three (3) years, whichever is shorter.
